PUBLIC HEARINGS:

1. A PUBLIC HEARING TO CONSIDER THE APPLICATION OF 1025 OCR LLC FOR SITE PLAN REVIEW FOR THE PREMISES LOCATED AT 19 STATE STREET, WESTBURY AND DESIGNATED ON THE NASSAU COUNTY LAND AND TAX MAP AS SECTION 11, BLOCK 79, LOTS 242-245, 253-256, 258, 259, 271-273, 313, 315-317 & 319.

Synopsis: The proposed action is the demolition of two buildings and the creation of 108 additional parking spaces on a 60,422 s.f. (1.39-acre) site for use by occupants of an offsite building (1025 Old Country Road).

2. A PUBLIC HEARING TO CONSIDER THE ADOPTION OF AN ORDINANCE AFFECTING LINDEN STREET, HERRICKS, NEW YORK.

Synopsis: The proposed ordinance would authorize installing a stop sign on Linden Street at its intersection with Pine Street.

3. A PUBLIC HEARING TO CONSIDER THE ADOPTION OF AN ORDINANCE AFFECTING CENTER DRIVE, HERRICKS, NEW YORK.

Synopsis: The proposed ordinance would authorize installing a stop sign on Center Drive at its intersection with Pine Street.

4. A PUBLIC HEARING TO CONSIDER THE ADOPTION OF AN ORDINANCE AFFECTING WEST STREET, HERRICKS, NEW YORK.

Synopsis: The proposed ordinance would authorize installing a stop sign on West Street at its intersection with North Street.

5. A PUBLIC HEARING TO CONSIDER THE ADOPTION OF AN ORDINANCE AFFECTING THIRD AVENUE, NEW CASSEL, NEW YORK.

Synopsis: The proposed ordinance would create a reserved parking space on Third Avenue in New Cassel.

6. A PUBLIC HEARING TO CONSIDER THE ADOPTION OF AN ORDINANCE AFFECTING STATION ROAD, GREAT NECK, NEW YORK.

Synopsis: The proposed ordinance would restrict parking to three hours on the north side of Station Road in Great Neck.

7. A PUBLIC HEARING TO CONSIDER THE ADOPTION OF A LOCAL LAW AMENDING CHAPTER 28 OF THE TOWN CODE OF THE TOWN OF NORTH HEMPSTEAD ENTITLED "HOUSING, REHABILITATION AND PROPERTY MAINTENANCE CODE."

Synopsis: The proposed local law would require that paint used to cover over graffiti be of the same or substantially similar color as the surface upon which the graffiti was made.

Synopsis: The proposed local law would correct a reference error in Section 2-35(U) of the Town Code concerning the suspension or revocation of plumbing licenses and certificates of competency and make further reference changes in Section 2-72 of the Town Code with regard to the suspension or revocation of electrical licenses and certificates of competency.

Synopsis: The adoption of this ordinance would establish a reserved parking space on the northeast side of Railroad Avenue, east of Siegel Street, in Westbury. Tentative hearing date is September 27, 2018.

WHEREAS, 1025 OCR LLC, (the "Applicant") has applied (the "Application") to the Town to demolish two buildings and create 108 additional parking spaces on a 60,442 s.f. (1.39 acre) site for use by occupants of an offsite building (1025 Old Country Road) at the premises located at 19 State Street, Westbury and designated on the Nassau County Land and Tax Map as Section 11, Block 79, Lots 242-245, 253-256, 258, 259, 271-273, 313, 315-317 & 319 (the "Premises"); and

WHEREAS, it has been determined that the Application requires site plan review pursuant to Town Code § 70-219 ("Site Plan Review"); and

WHEREAS, all necessary reports, recommendations, and comments on the Project have been filed with this Board by the Commissioner of Planning and Environmental Protection (the "Planning Commissioner") pursuant to Town Code §70-219(A)(4); and

WHEREAS, the Town Clerk, pursuant to and in accordance with Town Code §§70-219(F)(1) and 70-240(A), has published notice of a public hearing scheduled for September 6, 2018 for the site plan review (the "Public Hearing"), as authorized and directed by the Town Board pursuant to Resolution No. 368-2018, adopted on August 14, 2018; and

WHEREAS, the Applicant has furnished proof of service of notice of the Public Hearing to the affected property owners within a 300-foot radius of the Premises as required by \$70-219(F)(2) of the Town Code, and filed an affidavit as to the mailing of such notices as required thereunder; and

WHEREAS, the Nassau County Planning Commission (the "Commission"), pursuant to General Municipal Law § 239-m, received and reviewed copies of the site plan and recommended local determination via letter dated August 29, 2018; and

WHEREAS, the Town's Department of Building Safety, Inspection and Enforcement (the "Building Department") issued a Notice of Disapproval on March 29, 2018, citing the following items: (a) the proposed action provides for two (2) parking spaces along Brooklyn Avenue and nine (9) parking spaces along State Street within the required 10 foot front yard setback required pursuant

to Town Code § 70-103(M); and (b) the proposed action requires Town Board approval pursuant to Town Code § 70-219(A); and

WHEREAS, on June 20, 2018, pursuant to Appeal No. 20524, the Town of North Hempstead Board of Zoning Appeals ("BZA") granted a variance to Town Code § 70-103(M); and

WHEREAS, the Planning Department has reviewed the Application and recommends approval of same: and

WHEREAS, it is required that a "lead agency" be established to review the Action pursuant to the rules and regulations for implementation of the New York State Environmental Quality Review Act as set forth in Title 6, Part 617.6 (b) of the Official Compilation of Codes, Rules, and Regulations of the State of New York ("SEQRA Regulations"); and

WHEREAS, the BZA has established itself as "lead agency" and has concluded that the Application, including the demolition of the buildings and the creation of the 108 additional parking spaces, constitutes an "unlisted" action pursuant to Section 617.2 (ak) of the SEQRA Regulations; and

WHEREAS, the BZA has further determined that the Action will not result in any significant adverse impacts on the environment based upon the analysis set forth in the Full Environmental Assessment Form (the "FEAF") for the reasons that the proposed Action will not (1) create a material conflict with an adopted land use plan or zoning regulations; (2) result in a change in the use or intensity of use of land; (3) impair the character or quality of the existing community; (4) have an impact on the environmental characteristics that caused the establishment of a Critical Environmental Area; (5) result in an adverse change in the existing level of traffic or affect existing infrastructure for mass transit, biking or walkway; (6) cause an increase in the use of energy and it fails to incorporate reasonably available energy conservation or renewable energy opportunities; (7) impact existing public or private water supplies or wastewater treatment utilities; (8) impair the character or quality of important historic, archaeological, architectural or aesthetic resources; (9) result in an adverse change to natural resources; (10) result in an increase in the potential for erosion, flooding or drainage problems; or (11) create a hazard to environmental resources or human health; and

WHEREAS, the Board wishes to concur in the BZA's determination that the Action constitutes an "unlisted action" and not an excluded or exempt action as defined in Section 617.2 (p) or (q) of the SEQRA regulations and not included in statewide or individual agency lists of Type I or Type II actions, and which will not result in any significant adverse impacts on the environment; and

WHEREAS, this Board has carefully considered the Application, testimony and other relevant evidence at the Public Hearing held on September 6, 2018, and afforded all interested persons the opportunity to be heard; and

WHEREAS, this Board now wishes to render a decision on this Application.

NOW, THEREFORE, BE IT

RESOLVED that the Board recognizes that the BZA has designated itself "lead agency" under the SEQRA Regulations for the Action; and be it further

RESOLVED that the Board concurs in the BZA's conclusion that the Action is an "unlisted action" which will not result in any significant adverse impact on the environment, based upon the analysis set forth in the FEAF, and upon the testimony and reports adduced at the Public Hearing; and be it further

RESOLVED that this Board finds that the Application and site plan are in compliance with Chapter 70 of the Town Code, and this Board further finds that the site plan is consistent with the spirit and intent of Town Code §70-219; and be it further

RESOLVED that, pursuant to Town Code §70-219(B), the site plan is hereby approved; and be it further

RESOLVED that a copy of this approval shall be filed with the Commissioner of the Building Department (the "Building Commissioner"), and the Building Commissioner is hereby authorized and directed to issue a building permit, upon compliance with the building permit application requirements as set forth in the Town Code, and any other conditions or requirements imposed by any other governmental entity having jurisdiction over the property, and to take such other action as may be necessary to effectuate the foregoing.

When a covering is used, the cover must be the same or similar color as the surface upon which the graffiti was made. Responsibility for removal or covering of graffiti shall lie with the owner or occupant, notwithstanding that said person may not have created the graffiti.

C. Any person who creates graffiti in any manner shall be liable for the cost of removing or covering the same.

Subdivision U of Section 2-35 of Chapter 2 of the Town Code is hereby amended as follows:

- U. Suspension and Revocation of Licenses
- (1) Subject to compliance with the requirements stated in subsections (2) and (3) below, the Commissioner of Buildings may revoke (or suspend for a period of up to one year) a certificate of competency or license granted under the provisions of this Article for any of the following reasons:
- (a) Failure to file an application for a permit prior to the installation of plumbing work; or
- (b) Failure to take the required action called for upon receipt of a violation notice; or
- (c) Performance of plumbing work in violation of the requirements of this Chapter; or
- (d) Renting or lending a license to a third party (see, section 86 42, below); or
- (e) Being convicted of a felony; or
- (f) Altering or defacing a certificate of inspection or approval; or
- (g) Filing an application to perform plumbing work for a person not licensed by the Town of North Hempstead.
- (2) Any suspension or revocation pursuant to Subsection (1) above may only be effected after a hearing by the Examining Board of Plumbers on the proposed suspension or revocation. The notice of hearing shall state the date, time and location of the hearing and the reasons (as stated in Subdivision (1) above) forming the basis for the proposed revocation or suspension. The notice of hearing shall be served either personally or by certified mail, return receipt requested, to the licensee's last known address at least 10 days prior to the hearing. The licensee shall have an opportunity to appear and be heard in relation to the proposed revocation or suspension, and may be represented by counsel. Minutes of the hearing shall be transcribed by a court reporter. The Commissioner of Buildings shall attend the hearing. The hearing shall be considered a "quasi-judicial proceeding" for purposes of Article 7 of the New York Public Officers Law.
- (3) Within ten (10) days of the hearing, the Examining Board of Plumbers shall present the Commissioner of Buildings with its recommendations as to whether to suspend or revoke the certificate of competency or license. Upon receipt of the recommendations, the Commissioner of Buildings may either accept or reject the Examining Board of Plumbers' recommendations and

revoke or suspend the certificate of competency or license. The revocation or suspension shall be effectuated by notice to the licensee by personal service or by certified mail, return receipt requested. **Section 3.**

Section 2-72 of Chapter 2 of the Town Code is hereby amended as follows:

§ 2-72 Suspension or revocation of license.

The Commissioner of Buildings may revoke or suspend a certificate of competency or license pursuant to § 2-68(G) of this Article a license for a period of not more than 30 days, where it has been determined that a licensee has submitted a false application or made false statements in obtaining such license or any renewal or has repeatedly failed to perform the work engaged in under the authority of such license in a competent and satisfactory manner or has violated the restrictions in the use of such license as set forth in § 2-69 of this article. In all instances of any suspension or revocation hereunder, the Commissioner of Buildings shall consult with the Examining Board of Electricians prior to his final determination. The Examining Board of Electricians, upon the receipt of any complaint resulting from work performed by licensees within a village, will conduct an independent investigation of such complaint before recommending to the Commissioner of Buildings the suspension or revocation of such Town license.

Section 4.
