Synopsis: The proposed local law would extend the building moratorium in the Waterfront Business (B-W) District until October 30, 2020.

RESOLUTION NO. 349 - 2020

A RESOLUTION SETTING A DATE FOR A PUBLIC HEARING TO CONSIDER THE ADOPTION OF A LOCAL LAW AMENDING LOCAL LAW NO. 2 OF 2020, ADOPTED MAY 19, 2020, TO EXTEND THE MORATORIUM IN THE WATERFRONT BUSINESS (B-W) DISTRICT.

WHEREAS, the Town Board, as the legislative body of the Town of North Hempstead, is empowered to amend the Town Code pursuant to the provisions of Article 9 of the New York State Constitution, the Town Law, and the Municipal Home Rule Law; and

WHEREAS, this Board, following a public hearing conducted on May 19, 2020, adopted Local Law No. 2 of 2020, which extended a building moratorium in the Waterfront Business (B-W) District (the "Moratorium") until September 14, 2020; and

WHEREAS, this Board now wishes to set a date for a public hearing to consider the adoption of a Local Law amending Local Law No. 2 of 2020, in order to extend the moratorium in the Waterfront Business (B-W) District through October 30, 2020.

NOW, THEREFORE, BE IT

RESOLVED that a public hearing be held by this Board on the 10th day of September, 2020, at 7:00 P.M. via Zoom, for the purpose of considering the adoption of a Local Law amending Local Law No. 2 of 2020, adopted May 19, 2020, extending the building moratorium in the Waterfront Business (B-W) District, in order to extend the Moratorium through October 30, 2020; and be it further

RESOLVED that the Town Clerk be and hereby is authorized and directed to publish a notice of the hearing as required by law, which notice shall be in substantially the following form:

PLEASE TAKE NOTICE, that effective immediately and based upon notices and health advisories issued by Federal, State and Local officials related to the COVID-19 virus, the Town Board of the Town of North Hempstead will not be holding in-person hearings. Until further notice, all future Town Board hearings and meetings will be held via videoconferencing, as permitted by the NYS Open Meetings Law. Due to public health and safety concerns, Town Board room will not be open to the public and there will be no in-person access to the hearing. The meeting will be broadcast live on the Town's website beginning at its regularly scheduled time at 7 P.M. There will be a Zoom link available for this 30 minutes prior to the start of the meeting.

PLEASE TAKE FURTHER NOTICE that all interested persons shall have an opportunity to be heard concerning the Local Law at the time and place advertised.
